OFFICE OF CLASSROOM MANAGEMENT 2019-20 Year in Review



In 2020, the Office of Classroom Management's (OCM) efforts helped address new challenges facing the University of Minnesota by ensuring access to safe learning spaces, aligning classes with new teaching modalities and guidelines, and supporting new technologies.

COVID-19 Safety and Preparedness

- Collaborated with University Services to support new HVAC systems, learning space cleaning protocols, and implement physical distancing standards.
- Developed and maintained multiple "Sunrise Plans" to ensure safe on-site work of OCM staff and student staff and for general-purpose space usage.
- Ensured access to more than 400 general-purpose classrooms by modeling 6' and 3' physical distancing layouts in under two weeks.
- Developed and placed 20,000+ chair signs and 5,000+ floor stickers to promote safe distancing and identify available seats.

Support for New Teaching Modalities

- Implemented newly defined class formats for use in summer 2020 and beyond: **In-person**, **Blended** (both in person and online/remote), **Remote** (fully online with synchronous meeting patterns) and **Online** (fully online with no set meeting patterns).
- Worked collaboratively with Twin Cities departments to review classes for changes that needed to be made due to changes in delivery format for summer 2020 and beyond.
- Executed revised production calendars and deadlines to better support faculty and students getting timely information.
- Moved final exams to an online format across campus.
- Worked with the Office of Information Technology to coordinate and support faculty and instructor readiness with proactive outreach and communication.



OCM prepared and supported an unprecedented number of classroom upgrades for instructors to support new class modalities.




New Technology


